- Parker acknowledged that the Staff did an excellent job in their support of the High Country Development Regulations.

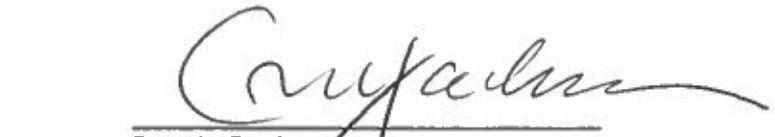
