

**RESOLUTION NO. 2013-001**

**A RESOLUTION OF THE  
BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO  
REGARDING CRIME INSURANCE AND BONDS FOR ELECTED OFFICIALS**

**WHEREAS**, Title 30, Article 10, Parts 1 to 9, C.R.S. make certain provisions regarding the elected officers for Colorado counties, including the requirements for bonding or insurance for such offices; and

**WHEREAS**, Title 30, Article 10 permits crime insurance to be obtained by the County as an alternative to officials providing bonds in order to protect the people of the county from any malfeasance on the part of the officer while in office or malfeasance of county employees; and

**WHEREAS**, the Board is advised that Ouray County has crime insurance in place for all elected officials who will take office in January 2013 and their appointed deputies, with such crime insurance being in the amount of \$150,000.00 for each officer or deputy, an amount in excess of that required for county officers per statute; and

**WHEREAS**, the Board has considered, pursuant to the provisions of C.R.S. §30-10-701 the amount of crime insurance coverage for the Ouray County Treasurer to protect the people of the county from any malfeasance on the part of the treasurer while in office and the Board has determined that the crime insurance coverage in the amount of \$150,000.00 is a sufficient amount; and

**WHEREAS**, pursuant to the provisions of C.R.S. §38-37-102((2)), the Board approves the bond of the Ouray County Public Trustee and deputies in the amount of \$25,000.00 for each; and

**WHEREAS**, pursuant to the provisions of Title 24, Article 13, C.R.S. regarding official bonds, to the extent that such statutes require the Board to examine and inquire into the sufficiency of the official bonds for elected county officers and make note of such examination in the records of the Board, the Board hereby determines that the crime insurance as described herein and the bond for the Public Trustee and deputies are deemed sufficient pursuant to the requirements set forth in Title 30, Article 10, parts 1 through 9 and C.R.S. 38-37-102(2).


**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO, AS FOLLOWS:**



That the crime insurance as provided by CAPP coverage through County Technical Services, Inc. in the amount of \$150,000.00 for each county officer and their deputies, including the County Treasurer, is deemed sufficient for purposes of the requirements set forth in Title 30, Article 10, Parts 1-9.
2. The Board approves the Bond for the Ouray County Public Trustee in the amount of \$25,000.00 as required by the provisions of C.R.S. §38-37-102.




