

RESOLUTION No. 2013-027

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO AMENDING RESOLUTION 2013-2009 CONCERNING THE ESTABLISHMENT OF THE OURAY COUNTY PUBLIC HEALTH AGENCY

WHEREAS, SB08-194 ("Public Health Reauthorization Act" referred to herein as the "Act") was adopted by the Colorado General Assembly during the 2008 legislative session and was signed into law by the Governor of the State of Colorado; and

WHEREAS, SB08-194 seeks to revise the public health laws of the State of Colorado in an effort to ensure that quality, essential public health services will be provided to the citizens of the State of Colorado; and

WHEREAS, the provisions of SB08-194 require that each county establish and maintain a county public health agency or participate in a district public health agency; and

WHEREAS, this resolution is intended to comply with the requirements of SB08-194 and C.R.S. § 25-1-501, *et seq.* by establishing the Ouray County Public Health Agency.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF OURAY COUNTY, COLORADO, AS FOLLOWS:


1. The Board establishes and will maintain the Ouray County Public Health Agency ("Agency") as the county public health agency.
2. The Board is required to organize the Agency by the appointment of a county board of health and, pursuant to C.R.S. § 25-1-508(2)(c), the Board is authorized and shall serve as the Ouray County Board of Health ("Board of Health"). The terms of the members of the Board of Health shall coincide with their terms as commissioners and such county board shall assume all of the duties of an appointed board of health as set forth in the Act.
3. At the organizational meeting of the Board of Health, the members shall elect a president and other officers as it shall determine.
4. Regular meetings of the Board of Health shall be held at least once every three months at one of the regular or special Board meetings of the Board of County Commissioners in January, April, July and October of each year, beginning on April 6, 2009, and at such other times that may be determined by the Board of Health.
5. Pursuant to C.R.S. § 25-1-508(5)(c)(I), the Board of Health shall appoint a Public Health Director of the Ouray County Public Health Agency and a Medical Officer for said Agency. The Public Health Director shall be Elisabeth Lawaczek and the Medical Officer shall be Michael Benziger, M.D.




