The Ouray County Board of County Commissioners typically designates a BOCC official as a delegate, member, or liaison to the following Ouray County Committees:

1. Road Committee (all BOCC members)

The Ouray County BOCC makes appointments of a BOCC member or other appointee for one or more year durations to the following Boards/Associations:

1. CCI Legislative Voting Member (summer each year to vote at the Legislative Meeting in October) -- must be BOCC member
2. CCI proxy for specific steering committees if desired.
3. Colorado River Water Conservation District (3-year appointment, 1st January meeting of the year to take effect)

12. Ouray County Water Users Association (County Attorney)
13. Public Lands Partnership – 1 member to Executive Committee – 3 year term
